SELECT CURRICULUM & PROGRAM DEVELOPMENT

- **Civic Studies Minor (Ball State University, 2025):** Developed and secured university approval for an interdisciplinary Civic Studies Minor integrating education, political science, ethics, communication, and related fields. This 15-credit minor is designed to prepare students for civic leadership, democratic engagement, and community impact.

RESEARCH INTEREST: My research examines how educational institutions cultivate civic agency: the knowledge, identities, relationships, and opportunities that enable young people and adults to participate in democratic life. Through community-engaged and school-based research, I study civic reasoning and dialogue, teacher learning, educational policy, and the institutional conditions that expand or constrain civic participation, particularly in historically underserved communities. My current work investigates how sustained school-university partnerships and professional learning networks can strengthen civic teaching and student participation at scale. My international scholarship extends this agenda comparatively by examining education, democratic development, and institutional reconstruction in Central and South Asia and Africa.
